



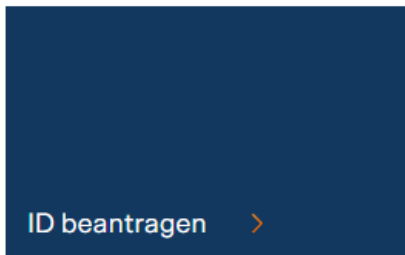

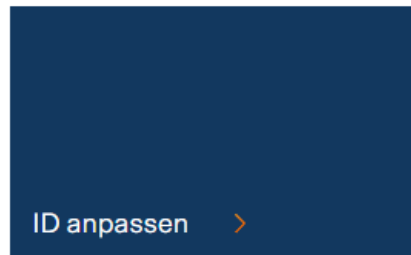
English Manual for Using the Swiss ID Register

The tool called "ID for charging station operators (CPO) and e-mobility providers (EMP)" is available in the Swiss national languages German, French and Italian. These instructions will help English speakers to use the tool in the German version.

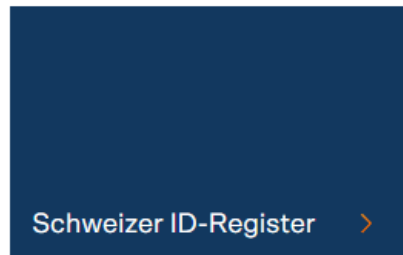
On the main page "ID for Charge Point Operators (CPO) and E-Mobility Providers (EMP)" you will find three buttons that direct you to the following subpages:



Request a new ID

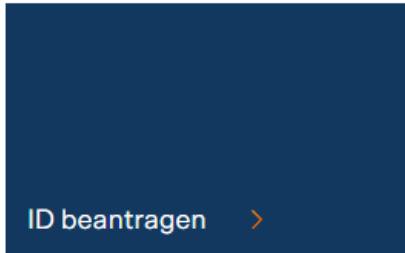

Request a new ID



As a charging station operator (CPO) or charging service provider (EMP) you can apply for your ID here. If you already use an ID you can have it entered in the register.

Please complete the form below (see next slide). **After you have submitted the form, you will receive an e-mail to which you must reply.** Your identity will be verified in this way. Your ID is only valid once it has been officially confirmed by the Swiss Federal Office of Energy (SFOE). Your ID is valid throughout Europe and can be viewed publicly in the national ID register.

Choose your role in the drop down: CPO, EMP or both. You can add more ID requests with the plus button.

The ID consists of 5 characters: CH-XXX. The country code CH is predefined, for the following 3 characters you can enter a desired combination of letters and numbers (e.g. ABC, R1G, 123). If you leave the field blank, you will be assigned a random ID.

In the [ID register](#) you can check which IDs have already been assigned. The Swiss Federal Office of Energy (SFOE) reserves the right to assign you a different ID if your desired ID has already been assigned or cannot be assigned for other reasons.

If your company is based in Switzerland, please enter your company identification number (UID) here. For foreign companies, please enter the value added tax identification number (VAT number).

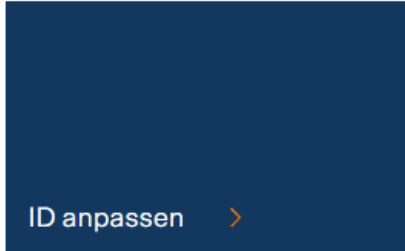

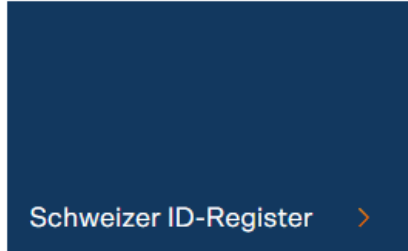
